## ACTIVITIES STANDARD TERMS AND CONDITIONS

1. Confirm your reservation by email or other written message and we send an invoice for settlement in advance to secure your places.
2. There are no refunds. In the event that –
  1. Any person cancels, you may replace them with others
  2. If we are forced by drought, flood or other conditions to alter a trip, we will do so at our discretion.
  3. If you must postpone cancel due to circumstances beyond your control, alternative dates are offered for mutual agreement, for an additional 5% fee.
  4. If you cancel and do not take up an alternative, the following fees apply:
    5. Over 21 days – deposit is forfeit
    6. 14-20 days – 50% of total fee
    7. Under 14 days – full fee remains due
3. Please do not be late. We may wait a few minutes for a late party but then the tour will go and there are no refunds or replacement trips for latecomers. Get the map and directions from us and do not rely on GPS.
4. **Please let us have your cellphone number to communicate if you are late or lost.**
5. At the venue, before any activities, participants must sign the Informed Consent & Assumption of Risk agreeing to undertake the trip and all associated activities at own personal risk. Parents or guardians must sign on behalf of minors. All must agree to abide by Covid protocols.

### ACTIVITIES:

6. Participants agree to obey the lawful instructions of the guides and to act responsibly. Trips begin with a safety briefing which must be carefully observed.
7. We reserve the right to refuse service.
8. The Lead Guide/manager must be informed of any disabilities, allergies or chronic conditions from which you may suffer. You must carry the necessary treatments or antidotes for yourself.
